Cooke served as a law clerk for the Honorable Sol Blatt, Jr., U.S. District Judge for South Carolina and as a governor's appointee to the South Carolina Joint Legislative Automobile Insurance Study Committee. He is past president of the South Carolina Bar, past president of the Charleston County Bar Association, past president of the Charleston Chapter of the American Board of Trial Advocates, past president of the James L. Petigru American Inn of Court, and past chairman of the South Carolina Bar's Commission on Judicial Independence and Impartiality.

Cooke serves on the South Carolina Bar's Committee on Judicial Independence and Impartiality. He is also a member of the Bar's Dispute Resolution Section Council and the Professional Liability Committee. He is a permanent member of the Fourth Circuit Judicial Conference and a member of the Defense Research Institute, the International Association of Defense Counsel (IADC), and the National Association of College and University Attorneys. He is a former member of the Fourteenth Judicial Circuit Public Defender selection committee.

In addition to his leadership roles within the legal community, Cooke is past president of the Board of Directors of East Cooper Community Outreach and has served on the board since its inception in 1989. He has been honored with ECCO's Stone Soup Award for outstanding service. Additionally, he has served as president of the East Cooper Breakfast Rotary Club and as vice chairman of the Rotary District 7770 Gift of Life Board of Directors.
